OVERVIEW: Steps to Obtaining Business Permits and Licenses



Use this as a checklist

- 1. Obtain a Fictitious Business Name (FBN) and advertise the FBN in a local newspaper.
- 2. Determine your business entity.
- 3. Apply for Proof of Residency.
- 4. Contact the California Department of Tax and Fee Administration for information on whether your business will need to file sales and use taxes. Apply for a seller's permit if your business will be reselling merchandise.
- 5. Contact the Inquiry and Illness Prevention Plan to get assistance to employers and workers about workplace safety and health issues.
- 6. Research additional local and state taxes that may be applicable to your business.
- 7. Apply for a business license tax and building and construction permits with the city or unincorporated area of the county that your business will be located in.
- 8. Apply for your EIN number for tax filing purposes.
- 9. Register with the California Employment Development Department (EDD) if necessary.
- 10. Apply for Corporation, Company, or Partnership Filings.
- 11. Comply with wage and hour requirements.
- 12. Apply for workers' compensation insurance.
- 13. Apply for police permits if necessary.

STEP 1: Obtain a Fictitious Business Name

If you plan to conduct business in a name other than your surname or the business has more than one owner you must file a Fictitious Business Name and publish it in a newspaper. You must run an ad in a major newspaper within 30 days of filing, once a week for four weeks. A list of approved publications will be provided to you at the time of filing. Proof of the run must be submitted within 30 days of the final run to the County Clerk's Office.

- A sole proprietorship requires a FBN if it is doing business with a name that does not contain the last name of the owner.
- A partnership or other association requires an FBN if it is doing business with a name that does not include the last name of each general partner or a name that suggests the existence of additional owners.
- A limited partnership, corporation or Limited Liability Company requires an FBN if it will be doing business with a name not stated in the Articles of Incorporation or Articles of Organization filed with the California Secretary of State.

STEP 2: Determine Business Entity

Prior to deciding what entity to select, it is important to make sure you understand the pros and cons of each. It may be worth discussing with a licensed California attorney. Depending on your business entity, you may need to register with the Secretary of State in addition to all other permits and licenses described in this document.

- If you choose to open your business as a sole proprietor, you do not need to register with the Secretary of State.
- For a general partnership you may register with the Secretary of State if you wish to do so.
- For a corporation (either stock or nonprofit), a limited liability company or a partnership (limited or limited liability), you must file with the Secretary of State's Office.

STEP 3: Apply for Proof of Residency

- Employees hired must provide proof of eligibility to work in the United States.

Call 800-375-5283 and the INS will provide employers the requirements for establishing proof of residency of employees.

STEP 4: Contact the CA Department of Tax & Fee Administration

Contact the California Department of Tax and Fee Administration for information on whether your business will need to file sales and use taxes.

This state agency is the governing body for sales and use tax and issues Seller's Permits. Any business that sells tangible personal property needs to obtain a State resale permit tax number from the California Department of Tax and Fee Administration. To determine if your business requires such a permit, you may first contact them by telephone. Be sure to check with the department below to determine if sales or use tax is applicable to your product or service and do not make assumptions that sales and use tax is not applicable to your business's product or service.

- Who must obtain a seller's permit?
 - You must obtain a seller's permit if you:
 - Are engaged in business in California and
 - Intend to sell or lease tangible personal property that would ordinarily be subject to sales tax if sold at retail.
- Do I need more than one permit?
 - If you have more than one place of business (located on different premises), you may need a separate permit for each location. In some instances it is possible to obtain a consolidated permit for multiple business outlets. At the time you apply for a permit, be sure to provide information for all business locations so that the CDTFA will issue the correct type of permit.
- How do I apply for a permit?
 - The CDTFA has a secure, convenient, fast, and free way to register online for a permit. The system guides you through the process and will assist you with the types of permits you may need for your business.

STEP 4: Contact the CA Department of Tax & Fee Administration- Continued

- If I apply for a permit, what information is needed to complete an application?
 - You will be asked to furnish the required information when registering for a permit, depending on the business.

STEP 5: Contact the Inquiry and Illness Prevention Plan

- Purpose: The Cal/OSHA Consultation Service provides assistance to employers and workers about workplace safety and health issues through on-site assistance, high hazard consultation and special emphasis programs, and develops educational materials on workplace safety and health topics. Virtually all business owners in the state of California are required to contact OSHA to report a workplace incident.
- Consultative assistance is provided to employers through on-site visits, telephone support, publications, eTools and educational outreach. All services provided by Cal/OSHA Consultation are provided free of charge to California employers.

- Opening a restaurant also means you must register for a **Health Permit**
 - A health permit is necessary for anyone to operate a food facility, and you must display this permit prominently displayed in your establishment at all time

STEP 6: Additional Local & State Taxes/Steps- Continued

- Opening a restaurant means that you must complete **State-specific Waste Discharge Requirements**. You must complete these requirements if your restaurant plans to discharge waste that could affect groundwater quality, which your restaurant likely will do. There are waste permits that are applicable at the city level, which is addressed below.

- In Santa Barbara?
 - Specific to Santa Barbara, there are certain **Land Use Permits** that you must apply for.

- Specific to Santa Barbara, you need a **Permit to Construct & Operate** if you plan on remodeling your restaurant, or if you are constructing your restaurant from scratch.

STEP 6: Additional Local & State Taxes/Steps- Continued

- Specific to Santa Barbara, you may need to complete the **Weights & Measures Registration Form** for the use of commercial weighing and measuring devices, package content statements, and advertised prices which are regularly inspected to ensure their accuracy.
 - The Santa Barbara Weights and Measures Division strives to "level the playing field" when weights and measures are involved in commercial transactions by ensuring accuracy with regard to a product's weight, volume, count, duration or advertised price.

STEP 7: Business License Tax and Construction Permits with the City

- Now that you have completed the steps above you can contact the city that you will be conducting business in to apply for your business tax license and building permit. All cities require a business tax license and building permit in order to operate. Visit your City Hall in person or online to obtain an application. At the time of filing the application, a fee must be paid and varies depending on the size and type of business. The license must be posted in plain sight at your place of business and must be renewed annually.

STEP 8: Employer Identification Number (EIN) filing Steps

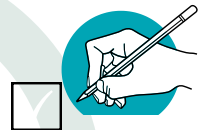
Purpose of EIN: An employer identification number (EIN) is similar to a personal social security number but for a business in that it allows the IRS to identify the business.

- **Step 1: Determine Your Eligibility**

- You may apply for an EIN online if your principal business is located in the United States or U.S. Territories.
- The person applying online must have a valid Taxpayer Identification Number (SSN, ITIN, EIN).
- You are limited to one EIN per responsible party per day.
- The “responsible party” is the person who ultimately owns or controls the entity or who exercises ultimate effective control over the entity. Unless the applicant is a government entity, the responsible party must be an individual (i.e., a natural person), not an entity.

- **Step 2: Compile Necessary Information**

- Date business started or acquired (month, day, year)
- Business entity type
- Closing month of accounting year
- Highest # of employees expected in the next 12 months (enter 0 if none)
- Expected employment tax liability to be \$1,000 or less in a full calendar year AND want to file Form 944 annually instead of Forms 941 quarterly
- First date wages or annuities were paid (month, day, year)
- Social Security Number



- **Step 3: Familiarize yourself with the Online Application**

- You must complete this application in one session, as you will not be able to save and return at a later time.
- Your session will expire after 15 minutes of inactivity, and you will need to start over.

- **Step 4: Submit Your Application**

- After all validations are done you will get your EIN immediately upon completion. You can then download, save, and print your EIN confirmation notice.

STEP 9: Register with the EDD

- If you operate a business and employ one or more employees, you must register as an employer with the Employment Development Department (EDD) when you pay wages in excess of \$100 in a calendar quarter.

STEP 10: Corporation, Company, or Partnership Filings

- If you are considering becoming a corporation, (either stock or nonprofit), a limited liability company or a partnership (limited, or limited liability), you must file with the Secretary of State's Office.
- The Secretary of State offers two options for submitting business entity filings depending on your entity and filing type.
 - File Online - Fastest Service
 - The business entity filings can be submitted directly online. Over 140 Business Filings, Name Reservations, and Orders for Certificates of Status and Certified Copies of Corporations, Limited Liability Companies and Limited Partnerships available online.

STEP 11: Wage/Hour Standards

Before an employee begins work, you must meet the following requirements:

- **A California Employer Identification Number:** An employer who becomes subject to the employment tax laws is required to register with the Employment Development Department (EDD) to obtain an identification number, which is the state equivalent of the federal tax identification number.
 - This number can be obtained by filing a DE-1 Registration Form with the EDD. After an employer receives the identification number, it will also receive information concerning all state required employment taxes and reporting requirements.

- **Workers' Compensation Insurance Coverage:** All employers are required to have workers' compensation insurance or receive state approval to self-insure the required benefits.
 - A large number of insurance companies offer plans for these benefits. In addition, the State Compensation Insurance Fund makes available such benefits to all employers.
- **Notice of Rights of Victims of Domestic Violence, Sexual Assault and Stalking:** All employers are required to provide a Notice of Rights of Victims of Domestic Violence, Sexual Assault and Stalking to all new employees and to existing employees when they request it.

- If an employer chooses not to use this form, its notice must be substantially similar in content and clarity to the form provided by the Labor Commissioner.

STEP 12: Apply for Workers' Compensation Insurance

The Division of Workers' Compensation (DWC) monitors the administration of workers' compensation claims, and provides administrative and judicial services to assist in resolving disputes that arise in connection with claims for workers' compensation benefits.

- **Purpose:** California employers are required by law to have workers' compensation insurance, even if they have only one employee. And, if your employees get hurt or sick because of work, you are required to pay for workers' compensation benefits. Workers' comp insurance provides basic benefits, including medical care, temporary disability benefits, permanent disability benefits, supplemental job displacement benefits and a return-to-work supplement, and death benefits.
- **Where do I get workers' compensation insurance?**
 - Employers must purchase workers' compensation insurance from either a licensed insurance company or through the State Compensation Insurance Fund (State Fund). Employers may also have the option to self-insure for workers' compensation.

APPENDIX 1: COSMETICS

Santa Barbara County, Santa Barbara City- Cosmetics: The following guide lays out the necessary licenses, permits and other materials that one must obtain if they are planning to sell cosmetics. These permits and licenses are what you, as the incorporator, have to obtain for your establishment. There are permits and licenses on the Federal, State, County and City levels. No matter what County or City you, as the person running the business, are from, the Federal and State licenses will be the same if you are in California. The guide below is for the City of Santa Barbara in Santa Barbara County.
